



#### **Public Lands Counties...**

- Work with federal partners to maintain and provide services for 610 million acres of land, or just over a quarter (28 percent) of all land acres in the country
- Are spread around the country; nearly twothirds (62 percent) of counties have federallyowned lands within our jurisdictions
- Manage federal funding, including more than \$578 million in federal Payment in Lieu of Taxes (PILT) funds and \$271 million from the Secure Rural Schools (SRS) funding program

## Public Lands in the East

- In the US, public lands are primarily managed by five federal agencies
- In the 31 eastern states, BLM manages over 40,000 acres of public land for multiple use
  - **Coal leasing** on Federal mineral estates with development potential
    - Approximately 39 million acres of federal mineral in the East
    - Generates over \$100 million a year for the Federal treasury in new rentals, royalties, fees and bonuses.
  - Works with the US Forest Service to analyze the potential for **developing new hard** rock deposit sites
  - Livestock grazing
    - Approximately 155 million acres of public lands
    - Administers nearly 18,000 permits and leases held by ranchers who graze their livestock on more than 21,000 allotments

## What We've Done


